Results of Survey on Organizational Issues

I am most pleased to send you a copy of the recent survey of members of the Alliance for Community College Innovation on organizational issues. This is the third report of our new presidential survey service for members of the Alliance.

Key results from this survey indicate that:

- Fifty-one percent of the presidents report that 5 to 8 staff serve on their cabinet or executive committee; the cabinet/executive committee meets weekly in 62 percent of the colleges.
- In the majority of the colleges (70 percent) 5 to 8 staff members report directly to the CEO.
- Almost one-third of all colleges have added a vice president position for institutional advancement; almost one-fifth of all colleges have added vice president positions for economic development and for technology.
- Two-thirds of the colleges have reorganized in the last three years,
  28 percent in the last year.
- Almost 50 percent of the colleges are moderately or extensively involved in TQM/CQI, and of these colleges, 49 percent find TQM/CQI approaches moderately effective to very effective.
